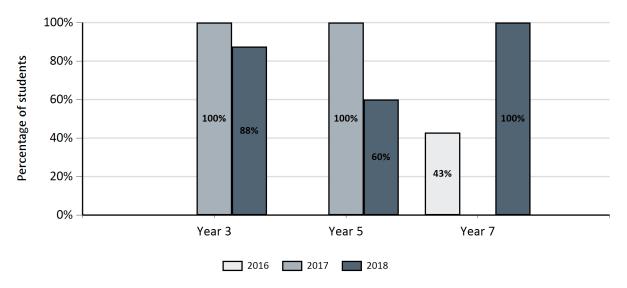

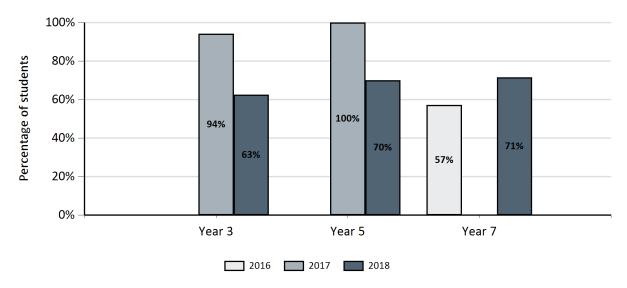
#### Reading
